

California Kids Consignment, LLC Sponsorship Agreement and Liability Release

LIABILITY RELEASE

- 1) CKC, LLC, Kirk Stauffer, Theresa Stauffer leaser and/or owner of space where the sales event is held, volunteers and/or paid participants of CKC, LLC, and insurer of CKC, LLC shall be held harmless, and released from liability with no claims for damaged, stolen, or lost property.
- 2) CKC, LLC, Kirk Stauffer, Theresa Stauffer, leaser and/or owner of space where the sales event is held, volunteers and/or paid participants of CKC, LLC, and insurer of CKC, LLC shall be released from liability and waived any and all claims for personal injury resulting from participation as a sponsor in the CKC, LLC, for all cause, whether foreseen or unforeseen.
- 3) Sponsors engaged in selling are responsible for conducting all sales transactions at their table and holds all required permits abiding by city, county, state, and federal laws relating to the exchange of currency for product/service. CKC, LLC shall be held harmless and released from liability with no claims pertaining to sponsorship business transactions when the event is open to the public.

PAYMENT

- 4) Sponsorship of the California Kids Consignment Sale, LLC is provided in the form of financial support in exchange for advertising and exposure on www.CalKidsConsignment.com, and/or consignment sales event, and/or CKC, LLC promotional materials. **Financial support to California Kids Consignment is non-refundable.** CKC, LLC holds the right to use sponsor name/company in promotional materials and advertising.
- 5) Table Sponsors must supply their own table and chairs. Sponsors are responsible for daily set-up and clean-up of their area. Sponsors choosing to stay at the event past their hourly agreement will be charged a rate of \$10.00 per/hour over their contracted time. Access to electrical outlets, phone lines, and other technological resources are unavailable.

TERMINATION

- 6) CKC, LLC holds the right to terminate sponsorship agreements and remove sponsor from event or website at anytime for conduct that is deemed unfavorable by CKC, LLC affiliates, consignors, volunteers, or customers.
- 7) Force Majeure: The Performance of this Agreement is subject to termination without liability upon the occurrence of any circumstances beyond the control of either party-such as acts of God, war, government regulations, disaster, civil disorder, location facilities closure, or curtailment of transportation facilities-to the extent that such circumstance makes it illegal or impossible to provide or use the location facilities. The ability to terminate this Agreement without liability pursuant to this paragraph is conditioned upon delivery of written notice to the other party setting forth the basis for such termination as soon as reasonably practical.

AGREEMENT

I hereby agree to be an Event Sponsor for the California Kids Consignment, LLC sale and to indemnify and hold harmless from any and all loss, liability or expenses, California Kids Consignment, LLC, Theresa Stauffer, Kirk Stauffer, including their representative agents and insurance carriers, from any liability, damages, losses, claims and expenses, howsoever caused, resulting directly or indirectly from or connected with the operation of California Kids Consignment, LLC sale event.
